

XBRL Europe membership benefits

1.What XBRL Europe is

XBRL Europe is a European organization consisting of existing European XBRL jurisdictions members plus XBRL International and direct members. Currently, the membership is comprised of 11 jurisdictions under Category 1 (amongst the 21 of XBRL International) and 15 direct members under Categories 2, 3 and 4. XBRL Europe has been set up in 2008 to foster European XBRL efforts, coordinate activities and to implement common XBRL projects in Europe with its members and specifically to liaise with European Authorities and organizations.

XBRL Europe has set up dedicated Working Groups where its members gather regularly by conference calls or Face to Face. These working groups are currently the EU Business Register Working Group, the Supervisory Reporting Working Group, the IFRS, Securities and Markets & Usability Working Group, the EU Adoption Committee and other dedicated adhoc committees as necessary

XBRL Europe organises twice a year European events, the so-called XBRL Europe day in winter and the XBRL Week in June coorganised with Eurofiling. These events are popular as at the last one in Frankfurt in the ECB premises 200 attendees have registered. These events mix regulators, users, software vendors and consultants. They are unique occasions to feel the evolution of the technology, the implementations and the market progress in Europe. They are unique occasions for our members to network and to appear for their own benefits.

XBRL Europe has reviewed its membership and has created new categories 2, 3 and 4 of members in 2016 as to be able to accept new type of members and to cope with a growing demand.



2. Members' category

The members' categories are the followings:

Cat 1: European XBRL Jurisdictions

Cat 2: European Institutions and European Federations

Cat 3: Non for profit Entities (Institutions, Federations, Associations) as well as for profit Entities incorporated in:

- 3.1 an existing XBRL jurisdiction Cat 3.1.1: NOT member of the existing jurisdiction Cat 3.1.2: member of the existing jurisdiction
- 3.2 in a country without a XBRL jurisdiction
- 3.3 in a country outside Europe

Cat 4: Individuals

All the direct members are in the Category 2, 3 and 4. The category 3 is comprised of "Premium members" and "silver members" with benefits attached and adapted fees as explained further.



3. What XBRL Europe offers to its members

XBRL Europe offers benefits to all its members according to their category and adapted to their status. XBRL Europe offers different levels of brand visibility to its members whether they are PREMIUM, or SILVER members as follows:
