XBRL Europe Foundation –

- > XBRL Europe: set up in 2008 to foster European XBRL efforts, coordinate activities and to implement common XBRL projects in Europe with its members and specifically to liaise with European Authorities and organizations.
- Founding members were (FR, BE, SP, NL, IE & XII) and currently, the membership is comprised of 11 jurisdictions (amongst the 21 of XBRL International) and 15 direct members thus 26 members (XBRL BE, DK, GE, FIN, FR, IT, LUX, NL, SP, SE, UK, XII) and direct members (The European Federation of Financial Analyst Societies, Bermuda Monetary Authority, Fujitsu Poland EMEA, Infogreffe, THEIA Partners, EY EMEIA, Bank Al Maghrib (Central Bank of Morocco), BR-AG Poznan, Atos International, UB Partner, AxiomSL, IRIS Business Services, GPM Systemy and IBM)
- > XBRL Europe Working Groups, Tasks Forces & Committees: XBRL Europe Business Register WG; Supervisory Reporting WG; IFRS, Securities and Markets WG; XBRL Usability WG; Multi Stakeholder Platform Task Force; EU Adoption committee and Adhoc commitees for various purposes like a 2016 Solvency II conference, like the preparations of XBRL Weeks; and the Adhoc commitee for the Strategic evolution
- > XBRL Europe governance: General Assembly, Executive Committee (Chair: XBRL Luxembourg Marc Hemmerling, Vice Chair: XBRL Belgium Camille Dümm, XBRL France Eric Jarry, XBRL Spain Ignacio Boixo, XII represented by John Turner (for the permanent seat reserved to XII, EFFAS represented by Hans Buysse (for the seat reserved to the Direct members); Secretary General Gilles Maguet

XBRL Europe limits & issues

- Today XBRL Europe has reached limits
 - ➤ In welcoming new members.
 - And Europe in forming new XBRL jurisdictions e.g. in small countries: sustainability at stake.
 - > And some existing jurisdictions are near to be not sustainable soon.
- So the major questions for the evolutions of XBRL Europe were:
 - > The positioning of XBRL Europe within the XII structure?
 - The coverage (membership) and the funding of XBRL Europe?
 - Solution for jurisdictions with on going problems to keep the XBRL initiative in their region alive?
 - How to deal with potential members disseminated in European countries where no jurisdiction exist?

XBRL Europe - Principle of the evolution



- The main objectives for the evolution was to add value to the XBRL consortium through:
 - encouraging participation of private companies and public institutions from countries with no existing jurisdictions in Europe,
 - contribute through activities to maintain continuing membership from existing jurisdictions,
 - Opening up the participation model to encourage European public sector involvement and improve the European coverage and representativeness of the association.
- Objective was to develop a financial model for XBRL Europe that combines a balanced budget with both sufficient funding to ensure continuing actions at European level and an agreed basis for direct members' contribution to XII.

XBRL Europe – Strategic Evolution



- ➤ Adhoc Committee formed (Hans Verkruijsse NL; Paul Snijders NL; Philip Allen UK; Hans Buysse EFFAS; Marc Hemmerling LUX; John Turner XII; Bruno Tesnière FR; Thomas Verdin Theia & FR; Esko Penttinen FIN; Noemi Di Segni IT; Björn Rydberg SE; Camille Dümm BE; Gilles Maguet SG XBRL Europe);
- Agreement with XII (Cees de Boer and John Turner) in Paris the 28th of May to present solutions at the Copenhagen conference
- 2 documents finalised
 - ➤ Strategic document finalised the 27th of July
 - ➤ Letter of Intent between XBRL Europe and XII finalised signed the 9th of September

Strategic document - New model proposed



- Membership Enlargement proposal
 - The members' category of XBRL Europe is modified to
 - 1) European XBRL Jurisdictions
 - 2) European Institutions and European Federations
 - 3) Companies and national institutions & national Federations
 - a) in an existing jurisdiction Option 1: not member of the jurisdiction, Option 2: member of the jurisdiction
 - b) in a country without jurisdiction
- Interim category (observer) is created on invitation only for Public authorities and other institutions: invited by the chair of an XBRL Europe Working Group approved by the ExCo of XBRL Europe to participate in such working group for one calendar year.

XBRL Europe/XII - Principle of collaboration **XBRL**



- ▶ In 2008 XBRL Europe was an initiative of European jurisdictions with full support of XII, since 2008 XII is participating to XBRL Europe board.
- > With a partnership mindset, both XBRL Europe and XII are committed to continue to work together in order to continue to support the development of XBRL in Europe
- > XBRL Europe's objective is also to continue to contribute to the financing of XII indirectly
 - through securing existing jurisdictions
 - >also directly via a financial contribution to the extent its own budget remain balanced after ensuring continuing actions at European level.

LOI - XBRL Europe/XII collaboration agreement



1) XBRL's consortium cross European activities

> XBRL Europe remain the main driver and point of contact towards European authorities and European wide organisations for the XBRL consortium. Its actions are defined and implemented via its executive committee where XII participates.

2) Membership status alignment

➤ Direct members of XBRL Europe may not be members of a local XBRL jurisdiction either because it does not exist or by obligation (EU institutions) or by choice (companies not member of a local jurisdiction). Although XBRL Europe is not a XII recognized jurisdiction of the consortium, XII will ensure that XBRL Europe members have equivalent rights to the consortium as if they were members of a local jurisdiction. For avoidance of doubt they will have access to XII members' restricted access of the web site, working groups and conferences.

3) Participation at the governance

To enable participation to the decision making process of XBRL Europe, XII is offered a permanent seat at the executive committee of XRBL Europe with full voting rights. XII participation to the governance is organised by its own status of association. One or more members of XBRL Europe may also, if elected, be member of XII board. Candidature of XBRL Europe executive committee members to XII board will be encouraged to facilitate dialogue between both organisations. Should no member of XBRL Europe executive committee are members of XII board, XII shall invite a representative of XBRL Executive committee to join the discussion of XII board for matters when European matters are debated.

4) Financing arrangements

- Considering that the sustainability of XBRL Europe is not to be jeopardized, after due consideration of i) incompressible budget of expenses required to ensure continuing activities and ii) that XBRL Europe members' contributions have already contributed to XII financial needs through local jurisdictions dues paid to XII. It has been agreed that XBRL Europe will contribute dues to XII on the following basis:
 - > The first 105.000 € of members' contribution collected by XBRL Europe will remain solely for the benefit of XBRL Europe (as of Budget 2015)
 - > 75% of any contribution collected by XBRL Europe on top of the first 105.000€ will be paid to XII up to 25.000 USD.
 - > Any further contribution collected by XBRL Europe will be shared on the basis of 1/3 to XII and 2/3 to XBRL Europe.
